The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Steve Dougan.

# **Meeting Agenda**

Commissioner Skelton amended the agenda to discuss LEST-II. Commissioner Gohagan made a motion to approve today's amended agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session opened at 10:01 A.M.

#### **Prior Minutes**

Commissioner Gohagan made a motion to approve May 1, 2025 meeting minutes. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

# **New Business**

**Bid Opening- R&B- Tire Recap Bid 250128-M –** Commissioner Dougan made a motion to accept the bids from Purcell Tire, Pomp's Tire, T&W, and McKnight Tire upon recommendation of the Camden County Road and Bridge Administrator. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

Sheriff – Agreement for Security Deputies' Services for 2025 – Shady Gators - Andy Prewitt and Sheriff Edgar were present for today's meeting. Both Andy Prewitt and Sheriff Edgar signed the security agreement for the Camden County Sheriff Department to provide security services in the areas known as Shady Gators, Horny Toad, and Camden on the Lake for the 2025 year. The only change to this contract from last year's contract is the dollar amount going up to \$78.32 per hour for the Deputy providing security services. Commissioner Dougan made

a motion to approve. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

# **Other Business**

Lakeview Resort – Andy Prewitt and Pat Wolf were present. They discussed the asphalt work completed so far. Andy had stated that he is committed to fixing any damage their development has caused and will need to figure out the condition of the road prior to development. Commissioner Gohagan wanted to know how much it would cost to finish the road. Pat Wolf said it would cost around \$40,000 and suggested that cost be split. Andy stated the proposal seemed fair but would need to get confirmation and authorization before any decisions could be made. No motions were made.

**LEST-II** – There was a discussion between the Commissioners, Sheriff, and Auditor regarding request to split fund 10. No motions were made.
