

COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Monday 05/12/2025

The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Steve Dougan.

Meeting Agenda

Commissioner Gohagan made a motion to approve today's working session agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session opened at 9:00 A.M.

Prior Minutes

There were no minutes present to be voted on.

Working Session Discussion

Court Circle and other streets/roads within City of Camdenton— Present from City of Camdenton for today's discussion over the matter of city limit roads were: City Administrator Jeff Hooker, Mayor John McNabb, and City Chief of Police Jeff Beauchamp. The Commissioners as well as the City Officials discussed various split roads within the county that may or may not be city roads, the logistics of maintaining such split roads, and if either the county or city would be interested in coming to an agreement for taking over portions of roads. Commissioner Skelton proposed to the Mayor that City of Camdenton take over a portion of Pier 31 Court from the last entrance of the Ozarks Amphitheater to the entrance of the MoDOT facility on North Hwy 5 in Camdenton; the county would take over Court Circle, which runs through the county's campus between the large parking lot and the Administration Building, with a drainage agreement pertaining to Primrose Lane. Camden County would also take ownership of Opportunity Road and the parking lot in front of the Justice Center and Administration Building at

the square in Camdenton. The Mayor stated he would have to go take a look at the portion of Pier 31 Court before making any decisions. Discussion on this matter ended at this time.

Commissioner Skelton made a motion to go into recess at 9:38 AM. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Gohagan (aye).

At 9:50 AM, Commissioner Skelton made a motion to come out of recess. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Gohagan (aye).


Other Issues/Communications/Updates-

1. Road and Bridge Administrator Pat Wolf was present and brought up the GPS tracking devices that have not been installed in all R&B equipment. He asked Commissioners for direction moving forward with the devices. Commissioner Dougan stated he would like to see the equipment being used since the county has paid for it. Mr. Wolf and Commissioner Dougan agreed that each of the GPS units could and would be installed in all necessary equipment by end of day Friday, May 23, 2025.
2. Human Trafficking Taskforce Equipment Discussion- Tena Riley was present. Commissioner Gohagan stated he thought it would be best for the equipment to be housed in Camden County and proposed the Sheriff's Dept. take control over inventory of equipment and signing it in and out to agencies who may need access to it. The last day to spend any funds for this Human Trafficking Taskforce grant is June 30, 2024. There were no official votes taken on this matter.
3. The Commission discussed consideration of offering a purchase price for the house located on the corner of the Camden County Campus just past the Public Administrator's Office.
4. Commissioner Dougan discussed upcoming items that may need added to an official agenda in the near future.


