The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Steve Dougan.

Meeting Agenda

Commissioner Skelton amended the agenda to add bid openings per publication in the local newspaper and discussion of old business concerning an amendment to the Purchase Order policy within the county's accounting policies. Commissioner Gohagan made a motion to approve today's amended agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session opened at 10:00 A.M.

Prior Minutes

Commissioner Dougan made a motion to approve the May 6, 2025 meeting minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Commissioner Dougan made a motion to approve the May 12, 2025 working session meeting minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

New Business

Bid Openings:

1. Sheriff- 2025 Vehicles- 250513-TP— There was one bid received: ESU Pursuits. Commissioner Gohagan made a motion to accept the bid by ESU Pursuits upon the request of the Camden County Sheriff. Commissioner Dougan seconded

the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

- 2. Jail Showers and Flooring- #250513-v- There were two bids received: Profinish Painting 1 and Stonhard. Head of Maintenance requested the Commission table this item on the agenda until Tuesday, May 20, 2025 to review the differences in the bids. Commissioner Gohagan made a motion to table this item on the agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).
- 3. Emergency Backup Generator 250120-B- There were three bids received:
 Norton Power Systems, Total Generator Service, Inc., and Reinhold Electric,
 Inc. Head of Maintenance requested time to review and compare the bids.
 Commissioner Dougan made a motion to table this bid award until Tuesday,
 May 20, 2025. Commissioner Gohagan seconded the motion. The motion
 passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan
 (aye).

LEST II- Discussion w/ Auditor and Sheriff- Discussion regarding the LEST fund split occurred between the Auditor, Sheriff, and Commission. Other budgetary issues pertaining to the Sheriff's budget were discussed at this time. There were no motions made.

Old Business

Purchase Order Policy- The amended policy requires a Purchase Order entry for any purchase over \$3,000 with exceptions for Road and Bridge and Utility bills as these routinely exceed that threshold. The Sheriff's Department recently brought to light that this PO policy hinders their dept.'s function because they also routinely spend more than \$3,000 on a weekly basis on items such as food for the jail and ammunition. Commissioner Gohagan made a motion to make an amendment to the exceptions portion of the policy to include the Sheriff's Department for routine expenditures and consumables. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

Adjourn: With no further official business on the agenda, Commissioner Dougan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Session closed at 11:38 A.M.
