Meeting Agenda

RFQ Opening- 250109 DMO Status- There was one submission for qualifications received, and it was from The Lake of the Ozarks Convention & Visitors Bureau. This is the original requesting entity to be dedicated as the DMO for LOZ before it was decided that the RFQ be put out. Commissioner Gohagan made a motion to appoint The Lake of the Ozarks Convention & Visitors Bureau as DMO and adopted the resolution stating so. Commissioner Dougan seconded the motion.

For the Official Destination Marketing Organization (DMO) for the Division of Tourism

K&M Clean Water 2025 service contract for operations and maintenance for sewer districts- The only change between last year's contract and 2025's contract is a 5% cost increase. The total cost for these services for 2025 is \$156,628.50. Commissioner Gohagan made a motion to approve this contract with K&M Clean Water. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

Accurate Accounting- 2025 management and financial contract for sewer districts- The only difference between last year's contract and 2025's contract is a 5% cost increase for services. The total cost for these services for 2025 is \$24,456.60. Commissioner Gohagan made a motion to approve this contract. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

Request for Surplus Funds- This request was reviewed by Jeff Green (County Counselor) and Kendra Hicks (County Treasurer) and approved. Commissioner Gohagan made a motion to approve this request for surplus funds in the amount of \$34,194.88. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

December 2024 Tax Abatements- Commissioner Gohagan made a motion to approve the December 2024 tax abatements previously tentatively approved by a commissioner or employee of the commission. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).
