Commissioner Dougan made a motion to appoint Chrissie Messina to the Camden County Sewer Board for a four-year term to expire January 31, 2029. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

**Surplus Funds Request- \$27,184.53-** This request for surplus funds application was generated by Teresa Murray (Collector), reviewed and approved by the County Counselor and Treasurer. Commissioner Dougan made a motion to approve this surplus funds request in the amount of \$27,184.53. Commissioner Gohagan seconded the motion. **Surplus Funds Request- \$33,829.90-** This request for surplus funds application was generated by Teresa Murray (Collector), reviewed and approved by the County Counselor and Treasurer. Commissioner Dougan made a motion to approve this surplus funds request in the amount of \$33,829.90. Commissioner Gohagan seconded the motion.
