

# COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Tuesday 01/28/2025

The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan and Second District Commissioner Steve Dougan.

## Meeting Agenda

Commissioner Gohagan made a motion to approve today's agenda.

Commissioner Dougan seconded the motion. The motion passed by vote:

Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session opened at 10:00 A.M.

## Prior Minutes

Commissioner Gohagan made a motion to approve the previous meeting minutes [1-23-25]. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

## New Business

**EMA- Annual Subaward Agreement- Generator Load Testing-** Commissioner Dougan made a motion to accept the federal grant funds in the amount of \$1,030.00 for generator load testing. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

**Budget Amendment- County Employee Health Fund-** This budget amendment is necessary to cover anticipated costs in 2025 for county employee health care costs. The Treasurer alerted the Commission that around the second week of January, this account was negative a significant amount. The Commission, Treasurer, and Auditor discussed a remedy to the issue and decided the budget amendment was needed. Commissioner Gohagan made a motion to approve the

budget amendment for \$400,000.00; moving money from the Miscellaneous County Revenue line to Health Care Provider Payments line. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). This budget amendment required a Certified Copy of Order directing the Treasurer to transfer the funds. Commissioner Gohagan made a motion to approve the court order. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

**2025 MAC Dues- \$9,488.00-** Commissioner Dougan made a motion to accept and pay the amount of \$9,488.00 for Missouri Association of Counties annual member dues. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

**Maintenance to discuss parking for county employees-** Discussion was held regarding the county growing and limited parking available for employees, citizens, and others when events occur at the county for different offices. Maintenance Supervisor Eddie Eidson recognizes Camden County is going to continue to grow and parking will be a larger issue down the road. The commission asked if anyone was present that would be willing to participate in a committee to come up with ideas that would alleviate some burdens around the Camden County campus. There were no motions made.

**Adjourn:** With no further official business on the agenda, Commissioner Gohagan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session closed at 10:44 A.M.
