

COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

The Camden County Commission met with First District Commissioner James Gohagan and Second District Commissioner Steve Dougan. Presiding Commissioner Ike Skelton was absent.

Camden County Clerk Rowland Todd appointed Second District Commissioner Steve Dougan as Presiding Commissioner for today's meeting.

Meeting Agenda

Commissioner Gohagan motioned to approve the agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Session opened at 10:00 A.M.

Prior Minutes

Commissioner Gohagan made a motion to approve meeting minutes from January 27, 2026. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

New Business

Discussion of updating Road & Bridge's phone system for offices- Patrick Wolf, R&B Admin., stated the phones they have and the current system they operate under are so old that no new handsets are operable. He stated that many times, people who call the office claim they cannot hear employees on the other end of the phones and calls get dropped. Rex with Missouri Bell Telecom, Camden County Administrative Offices' phone company, was unable to be present for the meeting today to discuss his plans for updating the phone system and moving Road and Bridge to the main cellular circuit that the other offices are in. Commissioner Gohagan made a motion to table this item on the agenda until Thursday, February

5, 2026. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

2026 Missouri Bell Telecom annual contract for services – The annual contract remained the same for 2024 and 2025. The contract was presented to the Commission again with one singular change—the one-time “Trip Charge” fee is set to increase to \$350 from \$300. Commissioner Gohagan made a motion to table this item on the agenda until Thursday, February 5, 2026. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

2026 Camden County Budget Appropriations Order— Commissioner Dougan made a motion to approve and adopt this 2026 Camden County Budget Appropriation Order. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Commissioner Dougan stated that the budget will be analyzed closely and if the revenue income does not look good come mid-year, the Commission will open the budget up for changes.

Adjourn: With no further official business on the agenda, Commissioner Gohagan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session closed at 10:05 A.M.
