The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan and Second District Commissioner Steve Dougan.

## Meeting Agenda

Commissioner Gohagan made a motion to approve today's agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye). Session opened at 10:02 A.M.

## Prior Minutes

## New Business

**Planning and Zoning Hearing-** Planning and Zoning Assistant Administrator, Brent Hubbard, states the rules and procedures for today's preceding. Commissioner Dougan made a motion to approve the Planning and Zoning agenda.

Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Commissioner Gohagan made a motion to approve the previous Planning and Zoning meeting minutes. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

**PZ24-0176 Webb- 1483 Old Morgan Road, Camdenton, MO 65020-**

**Rezone A-1 to A-R:** The applicant was not present. There were no parties present to speak in favor OR opposition to this matter. The Planning and Zoning Board recommends approval unanimously. Commissioner Dougan made a motion to approve the request rezone from A-1 to A-R.

Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

**Road and Bridge Bid Award- Willow Creek Bridge Construction-** Shannon Howe with Howe Engineering submitted a recommendation of bid award to the commission via email this morning. That recommendation was to accept Brenneke Construction, LLC's bid (which was the lowest bid) for \$494,379.30. Road and Bridge Administrator, Patrick Wolf, stated he agreed with Howe's recommendation. Commissioner Dougan made a motion to accept Brenneke Construction, LLC's bid for construction of Bridge #1670008- Willow Creek Road. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

At this time, Commissioner Skelton opened the floor for public comment. Sheriff Chris Edgar spoke up and thanked the Road and Bridge Department for their hard work and long hours during the snow storm this past week. Several in attendance spoke in agreement with Sheriff Edgar.

Commissioner Dougan brought up an idea previously mentioned: giving the Emergency Management Agency back to the Sheriff's Department as he believes the command structure fits better within all emergency/first responder agencies. Commissioner Gohagan stated he wouldn't be opposed to that and asked Sheriff Edgar if he'd consider moving 911 Mapping & Addressing to the EMA building and allowing Road and Bridge to utilize the entire Montreal shed. Sheriff Edgar stated he wouldn't be opposed to that. Commissioner Skelton requested to put this issue on the agenda for formal discussion and vote sometime in the next couple of weeks. There were no motions made.

**Adjourn:** With no further official business on the agenda, Commissioner Dougan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Session closed at 10:15 A.M.
