Tuesday 03/10/2026

The Camden County Commission met with Presiding Commissioner Ike Skelton and Second District Commissioner Steve Dougan. First District Commissioner James Gohagan was absent.

Meeting Agenda

Commissioner Skelton made a motion to amend the agenda to add discussion of an update on marijuana tax revenue under “other/old business”. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Dougan (aye). Session opened at 10:00 A.M.

Prior Minutes

Commissioner Dougan made a motion to approve the previous meeting minutes of March 3, 2026. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Skelton (aye).

New Business

Sheriff Budget Amendment- \$83.98 (donation)—Because the Sheriff’s Department received a donation of \$83.98, a budget amendment is required to increase revenue and expense lines so the money can be spent. Commissioner Skelton made a motion to approve the budget amendment for Public Safety Law Enforcement department in the amount of \$83.98. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Dougan (aye).

EMA to present updated COOP for Camden County – Unfortunately, a hazmat spill occurred this morning causing EMA Director Chris McNail to be absent for the meeting. Commissioner Skelton explained that due to the sensitive nature of the contents of the COOP, much of it couldn’t be released or discussed in public

anyway. The Commissioners acknowledged they have been made aware of the changes made within the COOP and see no issues. Commissioner Skelton made a motion to adopt the COOP with the updates. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Dougan (aye).

Surplus Funds Request— The County Legal Team and Treasurer have reviewed the request for surplus funds in the amount of \$25,687.37 and have given their blessing to approve this request. Commissioner Dougan made a motion to approve this request for surplus funds. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Skelton (aye).

Other/Old Business

Marijuana Tax Revenue- Per the last meeting, the Commission was waiting for Kendra Hicks to give an update from the Department of Revenue. The County is presented with two options: repay the amount of \$159,002.46 in full or allow the state to deduct monthly payments over a six-month period. Commissioner Skelton stated that no vote would be made today since the item is not officially noticed on the agenda.

Closed Session RSMo 610.021 #1- Commissioner Dougan made a motion to go into recess at 10:06 AM. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Skelton (aye). The meeting will reconvene in the Commission Office as a Closed Session.

At 10:30 AM, Commissioner Dougan made a motion to come out of recess. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Skelton (aye).

Commissioner Dougan made a motion to go into Closed Session. Commissioner Skelton seconded the motion. Roll-call vote was taken: Commissioner Dougan (aye), Commissioner Skelton (aye), Commissioner Gohagan (absent).

At 10:55 AM, Commissioner Skelton made a motion to come out of Closed Session. Commissioner Dougan seconded the motion. Roll-call vote was taken: Commissioner Skelton (aye), Commissioner Dougan (aye), Commissioner Gohagan (absent).

Adjourn: With no further official business on the agenda, Commissioner Dougan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Skelton (aye). Session closed at 10:55 A.M.
