

COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Tuesday 04/01/2025

The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan and Second District Commissioner Steve Dougan.

Meeting Agenda

Commissioner Dougan made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Session opened at 10:00 A.M.

Prior Minutes

Commissioner Dougan made a motion to approve the previous meeting minutes from March 28, 2025. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

New Business

CART Funds Distribution to Horseshoe Bend Special Road District- Commissioner Gohagan made a motion to approve the transfer of \$425,846.00 from Road and Bridge to Horseshoe Bend Special Road District for 2024 CART Fund reimbursement. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

Presentation by Ball Parks National- Consideration of Support- There was nobody present from Ball Parks National for today's meeting. Commissioner Gohagan made a motion to table this item on the agenda. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

Discuss Possible Revocation of Resolution 09-29-20-01- Allowing Banning of Individuals from County Property- Nathan Rinne was present to address this

topic on the agenda. He claims that the resolution is invalid and unenforceable and requested the commission revoke the ordinance based on Missouri State Statute (RSMO 49.266). Commissioner Gohagan made a motion to revoke Resolution 09-29-20-01. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

Remainder of Road and Bridge Spring Bid Awards-

1. 240128-Y Concrete Repairs, Additions, and Structures
 - a. Commissioner Gohagan made a motion to accept the bid submitted by Girard Concrete based upon the recommendation of the Road and Bridge Administrator. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).
2. 240128-W Hot Mix Asphalt Overlay
 - a. Commissioner Gohagan made a motion to accept the bid submitted by Capital Materials based upon the recommendation of the Road and Bridge Administrator. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).
3. 250128-N Grader & Snow Plow Blades
 - a. Commissioner Gohagan made a motion to accept the bid submitted by Foley Equipment (CAT) based upon the recommendation of the Road and Bridge Administrator. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).
4. 250128-M Tires
 - a. Commissioner Gohagan made a motion to reject all bids and put this portion of spring bids back out for bid. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).
5. 250128-L Roadway Signs, Cones, and Barricades
 - a. Commissioner Gohagan made a motion to accept Vulcan's bid based upon the recommendation of the Road and Bridge Administrator. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

6. 250128-F Diesel Fuel & Gasoline

- a. Commissioner Gohagan made a motion to accept Frisco Fuel's [option #1- pay market price] bid based upon the recommendation of the Road and Bridge Administrator. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Dougan (aye).

7. 250128-B Batteries

- a. Commissioner Dougan made a motion to accept all bids based upon the recommendation of the Road and Bridge Administrator. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye).

Discuss Road and Bridge Personnel- At this time, Commissioner Skelton asked a citizen to come forward and address their issue which was also a Road and Bridge concern. Tom Abbett with the Ozarks Amphitheater came forward and presented a solution for the traffic build up that occurs during concert season. Pat Wolf stated that the shoulders could be widened 6' on each side to provide room for a third lane. One lane would be a dedicated turn while still having one functioning driving lane. Pat stated the projected cost would be somewhere between \$75-100k. Mr. Abbett requested that the work not begin until after this year's concert season. Commissioner Skelton asked if Mr. Abbett would enter into a verbal agreement that Road and Bridge would pay for the dirt work and do the labor and Ozarks Amphitheater would pay for the asphalt which Pat Wolf estimates would be approximately half the cost of the project. Mr. Abbett agreed. There were no motions made.

Horseshoe Bend Special Road District is requesting an annual portion of the Road Impact Fees that are collected when permits are issued at the county. Their portion would come directly from permits issued on Horseshoe Bend. The commissioners, HSBSRD administrators, Road and Bridge Administrator, and the Planning and Permitting Department will have a meeting to establish how these fees will be split. There were no motions made.

Personnel- Pat Wolf requested the commission consider allowing him to use some of the funds that are being saved from the asphalt budget (approximately \$640k) to create three full-time positions for a ditch/pipe/canopy/flag crew, hire a seasonal crew of 4 people, and give current employees incentive raises. He

projects this would amount to \$387,383.00. Commissioner Skelton made a motion to utilize \$387,383.00 of the current Road and Bridge budget to create three full-time positions, 4 seasonal positions, and give employees incentive raises. Commissioner Dougan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Dougan (aye).

Adjourn: With no further official business on the agenda, Commissioner Dougan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Dougan (aye) and Commissioner Gohagan (aye). Session closed at 11:03 A.M.

Ordered that the Commission adjourn until further notice.
