- The vehicle is being sold as is-. Camden County Assessor's does not guarantee the condition of the vehicle. This was one of our fleet vehicles and has always been used to inspect Camden County properties. All miles are NOT highway miles. This vehicle does have several issues, and we will be upfront and honest about all questions to the best of our knowledge. You cannot remove the vehicle to take it to your mechanic to assess it, and you are not allowed to test drive the vehicle. However, you may inspect it and look at it here on site.
- Camden County Assessor's Office assumes no liability for loss or injury that may occur during inspection, bidding, or removal of the vehicle offered for sale or for loss or damage to property following the sale.
- All payments should be in the form of cash, check, or money order made out to "Camden County Assessor." Payments must be made before or at the time of pick-up.
- The purchaser is responsible for transporting the vehicle.
- The successful bidder has ten business days from the bid opening to make payment and remove the vehicle. Vehicle pickups must be scheduled by contacting Byron Willis by phone at 573-317-3811 or by email at byron_willis@camdencountymo.gov. All rights to and interests in the vehicle are forfeited at 4:30 p.m., ten business days from the date of notification of bid acceptance. The next highest bidder will then be notified and given ten business days from the notification to make payment and remove the vehicle.
- If bidding results in a tie, each bidder involved with the tie will be contacted and allowed to raise their bids until there is a winning bid.
- The successful bidder will be responsible for any damage to the vehicle while removing the vehicle.
